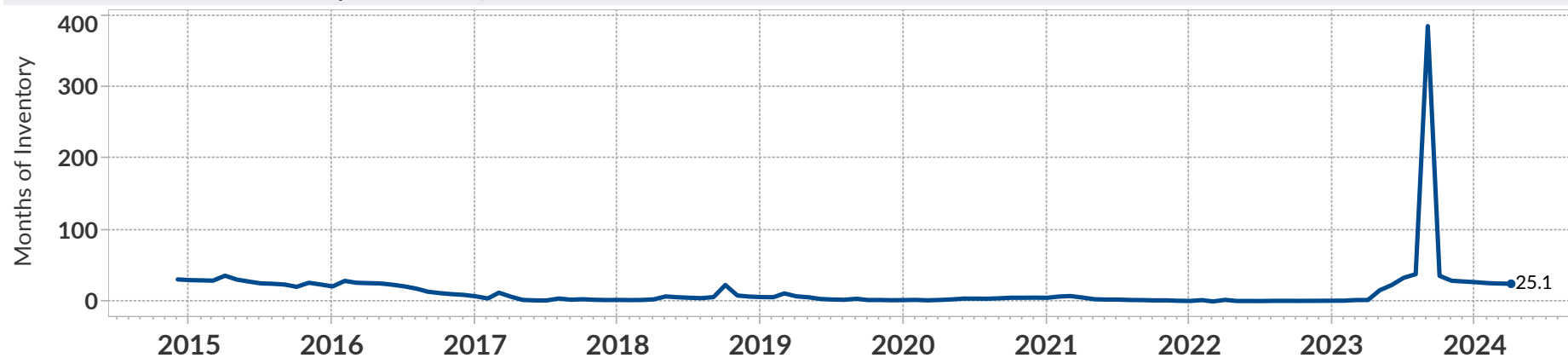

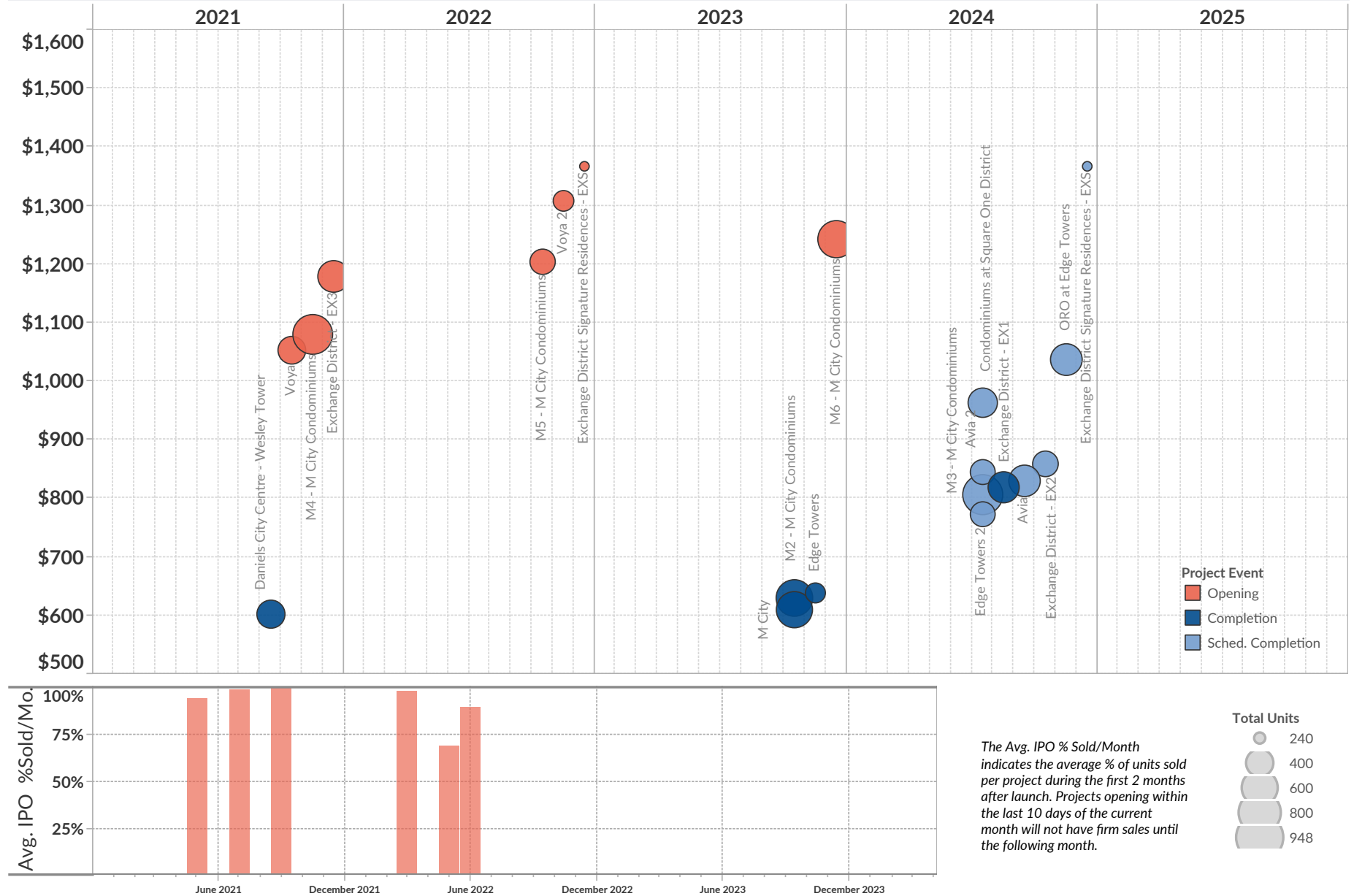

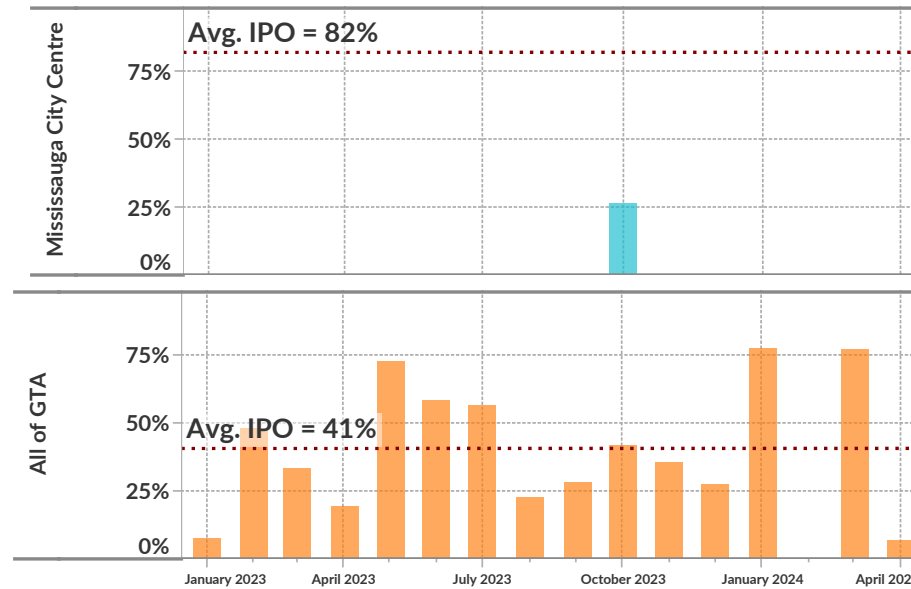

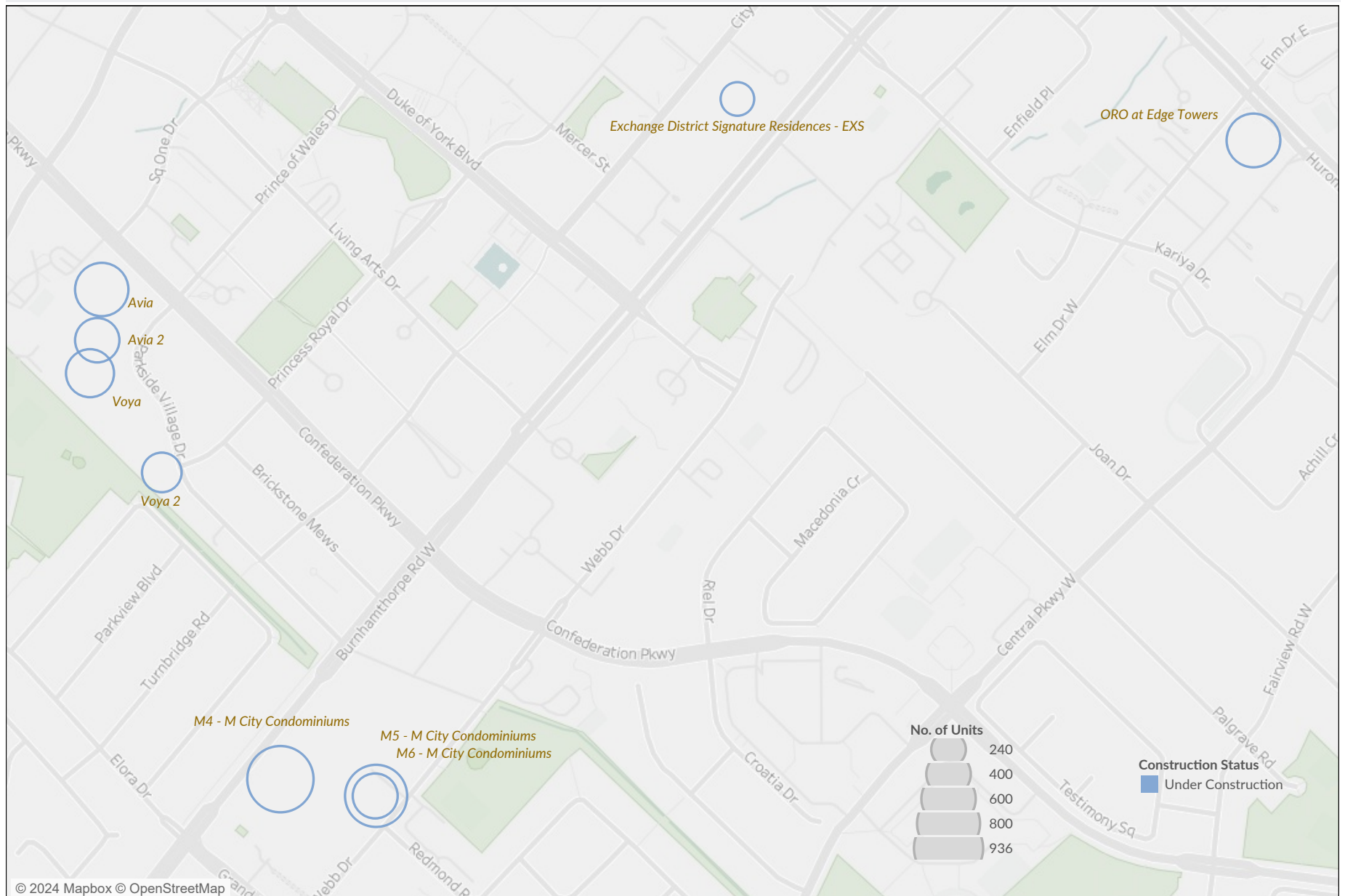


Post Launch Absorption: Mississauga City Centre
