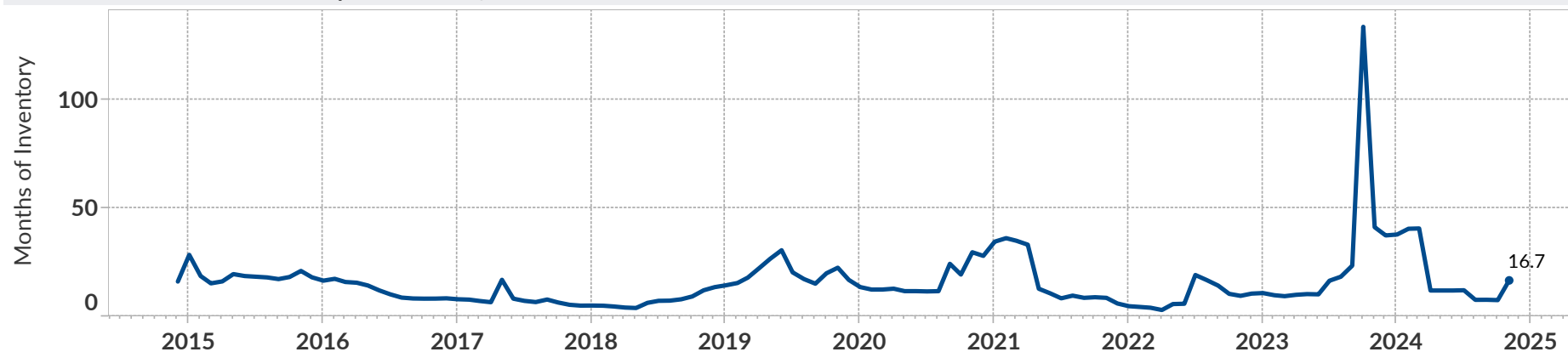

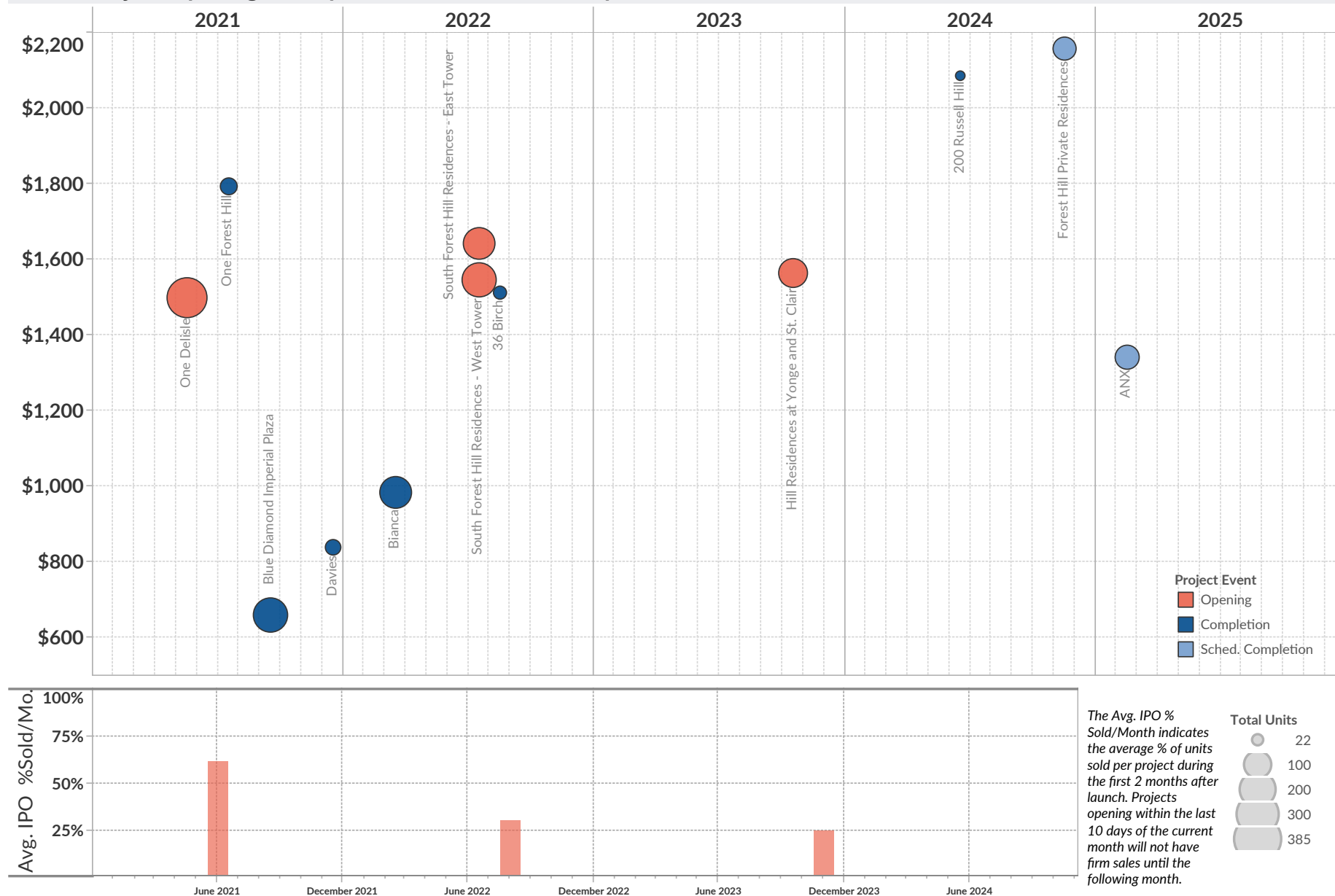

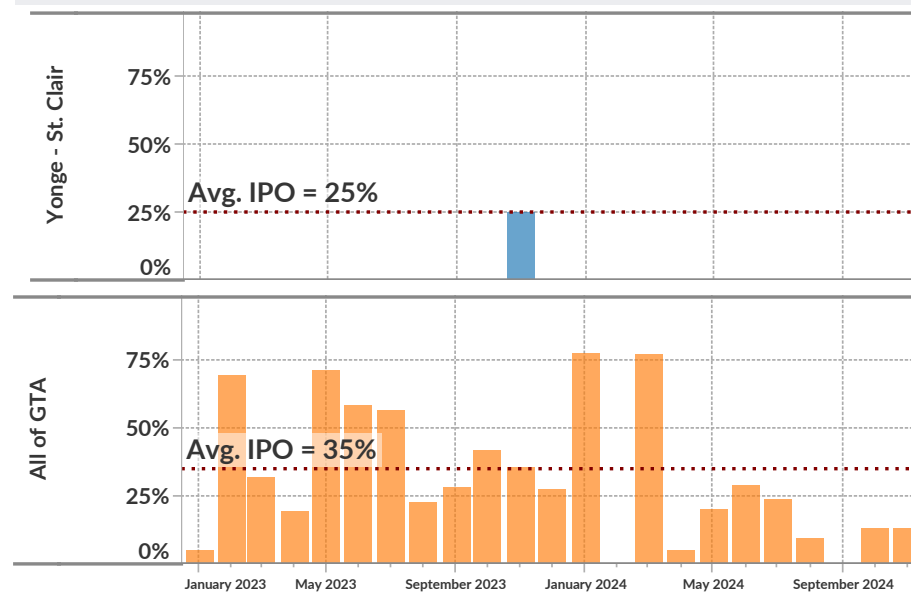

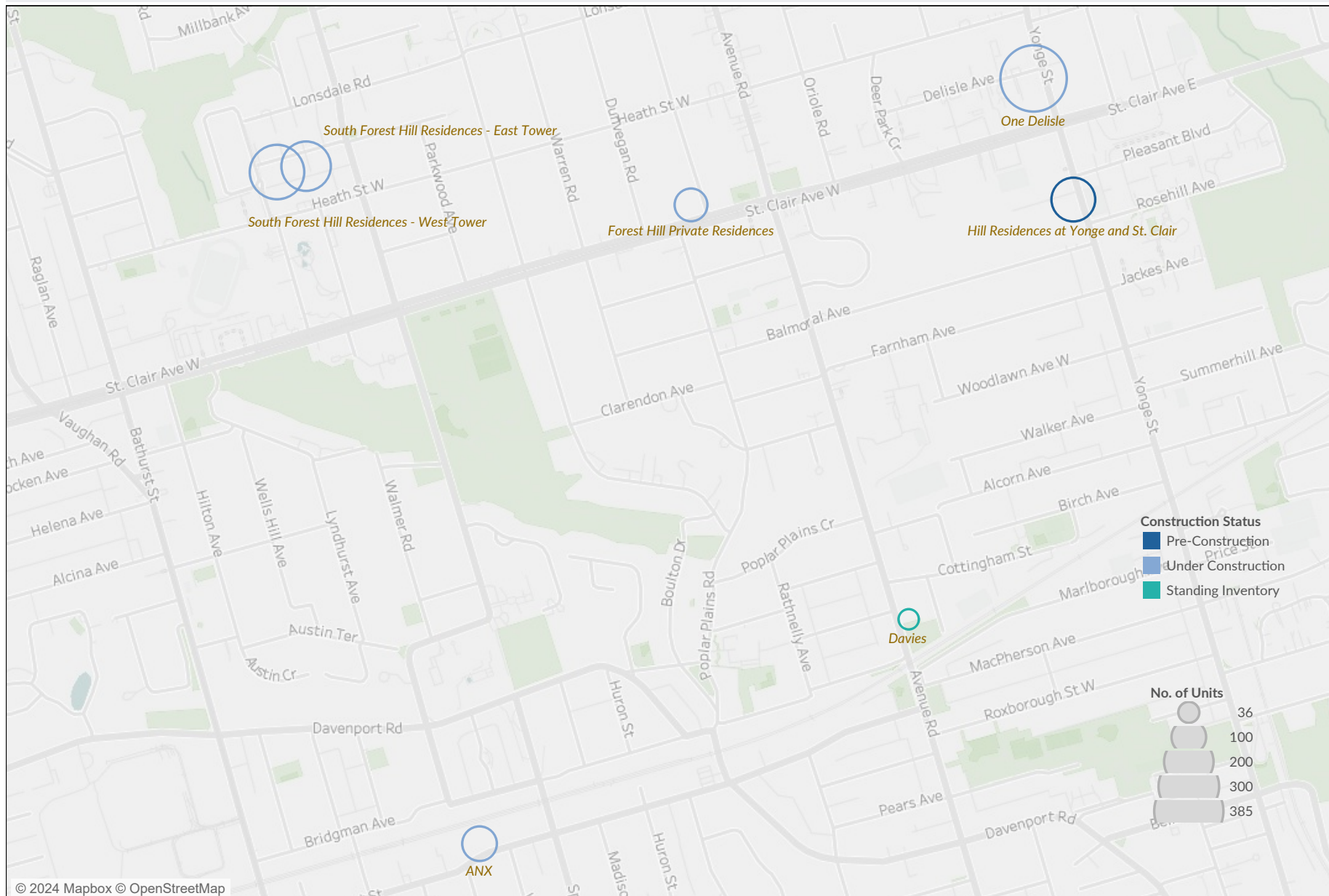


Post Launch Absorption: Yonge - St. Clair
